IF YOU HAVE RECEIVED THIS DOCUMENT, YOU HAVE PURCHASED EITHER A **SINGLE DAY SCHOOLING PASS**, OR A **7 MONTH SEASON PASS**.

BEFORE YOU RIDE, PLEASE REVIEW OUR **COMPULSORY REGULATIONS FOR 2010**. THESE RULES HAVE BEEN PUT IN PLACE TO ASSURE THE SAFETY OF ALL RIDERS AND HORSES ON OUR PROPERTY, AS WELL AS TO PRESERVE OUR VALUED FACILITY.

1. A COPY OF A 2010 NEGATIVE COGGINS RESULT FOR EACH HORSE ON THE PROPERTY MUST BE PRESENTED *BEFORE THE HORSE IS UNLOADED. IF NO ONE IS PRESENT, PLEASE LEAVE A COPY OF THE COGGINS WITH THE FEE.*

2. ALL NECESSARY WAIVERS MUST BE SIGNED BY RIDERS AND/OR THEIR PARENTS, AND FILED WITH THE FARM, *BEFORE THE RIDER MOUNTS. THESE WAIVERS INCLUDE, BUT ARE NOT LIMITED TO, 1) FACILITY USE AGREEMENT, (FOR TRAINERS) 2) HELMET AND SAFETY STATEMENT, 3) MINOR CONSENT FORM (FOR RIDERS YOUNGER THAN 18), AND 4) THE WAIVER OF LIABILITY.*

3. CHECKS MUST BE WRITTEN OUT IN FULL TO COPPER CREEK FARM *BEFORE THE RIDER MOUNTS (IF THERE IS NO-ONE PRESENT, PUT THE CHECK IN THE MAILBOX PROVIDED, NEXT TO THE FEED ROOM DOOR IN THE EAST BARN)*

4. NO TRAINER MAY GIVE INSTRUCTION TO ANY RIDER *WITHOUT HAVING BEEN PREVIOUSLY REGISTERED WITH JOHN FILIOS, COMPLETED THE FACILITY USE AGREEMENT, AND SHOWN PROOF OF LIABILITY INSURANCE.*

5. COPPER CREEK FARM RESERVES THE RIGHT TO MARK CERTAIN ELEMENTS OF THE COURSE AS OFF-LIMITS WHEN

CONDITIONS OF EITHER THE JUMP OR THE SURROUNDING FOOTING ARE UNFAVORABLE.

6. COPPER CREEK FARM RESERVES THE RIGHT TO ASK ANY RIDERS AND/OR TRAINERS WHO ARE DEMONSTRATING UNREASONABLY UNSAFE BEHAVIOR AND/OR DISPLAYING POOR HORSEMANSHIP *TO DISMOUNT AND/OR LEAVE THE PROPERTY IMMEDIATELY.*
